With reference to your application dated 14-02-2017 and subsequent correspondence with the school. I convey the grant for provisional DAV Sr. Sec. School Narwana Tehsil Dharamshala District Kangra, Pin-176052 (H.P) ( Name of school) for 1<sup>st</sup> to Class 8<sup>th</sup> for a period of Five Year w.e.f. 1<sup>st</sup> April 2017 to 31 March 2022. The above sanction is subject to fulfillment of following conditions:-

1. The grant for recognition is not expendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII.
2. The school shall abide by the provision of Right of Children to free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to free and Compulsory Education Rules, 2011 (Annexure II).
3. The Society/School shall not collect any capitation fee and subject the Child or his or her parent's guardians to any screening procedure.
4. The School shall not deny admission to any Child,
  - (i) For lack of age proof,
  - (ii) If such admission is sought subsequent to the extended period of ninety days for admission, and
  - (iii) On the ground of religion, caste or race, place of birth or any of them.
  - (iv) The School shall ensure that,
  - (v) No Child admission shall be held back in any class or expelled from school till the completion Elementary Education in that School.
  - (vi) No Child shall be subjected to physical punishment or mental harassment.
  - (vii) No Child is required to pass any Board examination till the completion of Elementary Education.
  - (viii) Every Child completion Elementary Education is awarded a certificate as laid down under rules 19 of the Right of Children to Free and Compulsory Education, Himachal Pradesh Rules, 2011.
  - (ix) Student with disabilities/ special needs are admission as per provision of the Act.
  - (x) The Teachers are recruited with minimum qualifications as laid down under section 23(1) of the RTE Act. The current teachers who. at the commencement of this Act did not posses minimum qualifications shall acquire such minimum qualification by March, 2019.
  - (xi) The teacher performs his/her duties specified under section 24(1) of the Act; and
  - (xii) The teacher performs shall not engage himself of herself for private teaching activities.
  - (xiii) The School shall follow the syllabus on the basis of curriculum laid down by academic authority under sub-section (1) of section 29.
  - (xiv) The School shall Enrol students proportionate to the facilities available in the school specified the section 19 of the Act.
  - (xv) The School shall maintain the standards and norms as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-
